INFORMATION ARTICLES 13 and 14 of EU Regulation 2016/679

Interested Subjects: E-commerce services users

3) <u>Profiling:</u> in order to improve the search for products that can satisfy you, we would like to use your data to define your profile, analyze consumption habits or choices, so as to suggest, in various ways, the offers deriving from your preferences, both through e-mails, newsletters, banners or messages dedicated to you.

The legal basis of the processing is the consent of the data subject.

Mandatory or optional nature of the data provision:

The provision of data for the purposes referred to in point (1) registration to the portal is necessary for the use of the ecommerce service, failure to provide the data requested as "mandatory" does not allow the Data Controller to adequately process data, therefore such information is considered mandatory.

The provision of data for the purposes referred to in point (2) Marketing and (3) Profiling is optional for you, any refusal to process your data does not compromise the continuation of the relationship or the adequacy of the treatment itself; in any case, you can exercise the right to revoke your consent even subsequently, both through the e-mails received (at the bottom of the text), and by requesting it through the contacts of the Data Controller.

Method of processing

Your personal data may be processed with mainly electronic and telematic methods such as:

- By means of electronic computers, on the web, using software systems managed by third parties, or programmed directly;

Recipients

Your data will be communicated exclusively to competent and duly appointed subjects, or identified as data processors - Article 28 GDPR, for the performance of the services necessary for a correct management of the relationship, with a guarantee of protection of the rights of the interested party.

Your data will be processed only by personnel expressly authorized by the Data Controller and, in particular, by personnel and companies responsible for the maintenance and updating of the site (web agency), for shipments (forwarding agents, post offices), and, if necessary, by the personnel appointed to marketing communications, analysis, and profiling possibly also through external companies.

Transfer of data to third countries: The Data Controller does not transfer personal data to countries outside the EU. If necessary, the interested parties will be informed in advance, and guarantee measures will be adopted for the transfer towards the recipients, which, depending on the case, may be: verification of the existence of adequacy decisions for the recipient country by the Commission, signing of standard contractual clauses, in the case of the USA

verification of adherence to international agreements in force; by way of derogation from such guarantees (in reference to Article 49 of the GDPR), the existence of a contract or pre-contractual measures in favor of the interested party or consent to the transfer is verified.

Dissemination: Your personal data will not be disclosed in any way.

Retention period. EU Regulation 2016/679: Articles 15, 16, 17, 18, 19, 20, 21, 22 - Rights of Data subjects

- 1. The data subject is entitled to receive confirmation as to the existence or non-existence of their personal information, even if it has not yet been recorded, and to its communication in intelligible form.
- 2. The data subject has the right to obtain information on:
 - a. the origin of the personal data;
 - b. the purposes and methods of data processing;
 - c. the logic applied in case of processing carried out with the aid of electronic devices;
 - d. the identity of the Data Controller, Data Processors, and designated representative pursuant to Article 5, paragraph 2:
 - e. the subjects or categories of subjects to whom the personal data may be communicated, or who can learn about them in their capacity as appointed representatives of the State, as designated managers or as persons in charge.
- 3. The data subject has the right to obtain:
 - a. updating, rectification or, when interested, supplementation of the data;
